Background

Systematic reviews of qualitative studies (qualitative evidence syntheses) are increasingly used to bring together findings from qualitative studies. In order to use synthesised findings to inform decisions we need methods to assess how much confidence to place in these findings. The GRADE-CERQual approach addresses this need.

Objectives

The objective of this workshop is to introduce the GRADE-CERQual (Confidence in the Evidence from Reviews of Qualitative research) approach to assess confidence in evidence from reviews of qualitative research.

Learning outcomes

To learn how to apply the GRADE-CERQual approach when assessing confidence in findings from qualitative evidence synthesis

Teaching strategies

In preparation for each of the four days of the workshop, participants will be expected to have viewed the videos listed below. During each day of the workshop, facilitators will give a short introduction on the topic of the day. Workshop participants will then carry out an exercise related to this topic, followed by a session where the topic and exercise are discussed.
